If you are not currently bowling in a local USBC certified league, you must supply a copy of either your current USBC card or your receipt for purchasing a USBC card. You **MUST** have a current USBC card in order to be a Delta 500 Club Member. **This rule applies to every member, including Life Members.**

The California Women's 500 Club' Annual Championship Singles Tournament in San Diego will begin on May 12, 2007 at Parkway Bowl, 1260 Fletcher Parkway, El Cajon, CA 92020, (619) 448-4111. The tentative ending date is July 29, 2007. The State 500 Club will be using scores from your Team Event scores ONLY. The entry to this tournament is \$15.00 plus a membership fee if you are not currently a member of the State 500 Club. The California Women's 500 Club's membership fee is currently \$15.00. Membership to the California Women's 500 Club is a LIFETIME membership. Replacement cards are \$ 2.00.

The Annual Meeting and Luncheon will be held at the Town & Country Hotel on Saturday, June 2, 2007. This meeting should begin at 10:00 a.m. and last until 12:00 p.m. Anyone interested in attending this Meeting and Luncheon, must let Trudy Trovinger know by April 1, 2007. The cost for the luncheon is \$30.00 per person.
